Date, Time and Location

McCourtie Market will be held on Saturdays May 7th to October 1st at McCourtie Park located at 10426 S. Jackson Rd. Cement City, MI 49233 from 10:00 am to 3:00 pm._____

Fees, Space and Setup

The 2022 Seasonal fee is \$50.00 for the entire 22-week season. Drop-ins are also welcomed. The Drop-in fee is \$10.00 per event. Vendor's space is 30' x 20'. Vendor Space will be on a "first come first serve basis" each week.

Applications and Agreements

Vendors must submit an application for review and approval. At no time can an approved vendor allow an unapproved vendor to bring in goods or allow them to use their vendor location for sales or advertising. Seasonal Vendor Applications must be received at Somerset Township by Wednesday, April 27, 2022. Drop-in Vendors must complete the application and have it on file by the end of business the Thursday prior to the Saturday in which you want to participate. Checks should be made payable to Somerset Township. Applications and payments can be made in person at Somerset Township or mailed to Somerset Township, 12715 E Chicago Rd, P.O. Box 69, Somerset Center, MI 49282

Displays and Signage

Vendors are required to display prices for their goods. Displays must be designed in a manner that will not block the view of other spaces or their goods and must not create an unsafe or hazardous condition. Displays and signage must be confined to vendors' rented areas.

Taxes and Regulations

All vendors are responsible for their own sales tax collection/payments and necessary permits/licenses required by the state and local government. All vendors must abide by all state laws and health department regulations. This also includes the "[Cottage Food](#)" law (if applicable)
